Time Limits for the IRS. Actually, the law gives the IRS eight additional months after that (for a total of 36 months, or three years), but auditors need to leave at least eight months in which the IRS can process appeals. This means that taxpayers need to keep their tax records and supporting documents for at least that long.

G. Administrative Appeal Procedures. The IRS must inform the requester of the reasons for the denial and the requester's right to appeal the denial to the head of the agency whenever an FOIA request is denied. A requester may appeal the withholding of a document or denial of a fee waiver request.
