Light Vehicle Registration and Fees. The owner of a light vehicle (passenger cars, pickup trucks one-ton and under, vans and sport utility vehicles) may choose one of the following renewal period options, MCA 61-3-311: 12-month registration - The owner pays one year of the registration rate, county option tax, all other registration fees and any special plate fees.

You are required by law to provide your current mailing address to the Motor Vehicle Division. Your license plate, tab and registration receipt will be mailed to the registration recipient's address on record at the time of the renewal.
